Session Abstract

Although the session questions why ancient people built giant stones for their burial sites and how this cultural practice persisted across various socio-economic contexts, it's clear

that megalithic culture cannot be limited to a specific historical region or time period. Instead, this phenomenon appeared worldwide, reflecting a common human tendency to commemorate death with monumental architecture. The endurance and adaptation of megalithic traditions across different societies suggest these structures held profound symbolic significance, serving not only as tombs but also as lasting symbols of community identity, spiritual beliefs, and social unity. Examining the continuity and changes in megalithic practices across different environmental and cultural settings, it provides valuable insights into the dynamic ways in which ancient communities navigated their relationships with mortality, memory, landscape and social organization. Their widespread presence highlights shared symbolic language and technological knowledge that crossed geographical boundaries.

In advance, we welcome researchers to share their contributions, drawing on both empirical and theoretical approaches, that explore the links between death, memory, landscape use, and long-term human-environmental and cultural interactions.
